We are a service for proxy verification (geo, protocols, service availability, presence in databases)

We are concerned for your trust and have developed this Privacy Policy in order to guide you in your decision to use our Services. This agreement constitutes a legal binding contract between you (“You”, or “User”) and us (“Company”, “We”, “Our” and “Us”). By accessing and using the Services, providing information to us in other formats, you agree to and accept the terms of this Privacy Policy, make timely changes to it, and consent to the collection and use of information in the manner described herein.

Should you disagree with the terms of this Agreement, please discontinue using our services immediately.

This Policy is further complemented by our License Agreement (EULA), which is incorporated herein by reference, and such other policies as we may notify you of from time to time.

### Data collected by us

The following types of data are collected from you by us when you use our Services:

#### Anonymized data

For the following reasons, we collect information about your use of our Services:

- To provide and improve our Services,
- To maintain the security of the Services, and
- To audit and statistically monitor demand for our services

This information is not personally identifiable; it only includes your approximate geographic location, hardware specifications, browser version and type, operating system type, version and language. We do not use this information to identify you.

The anonymized data that we collect assists us in determining whether you are currently using your computer in order to avoid additional enquiries.

#### Personal data

This is information of a private, sensitive or confidential character that identifies you or can identify you. We collect and store your personal information, including your IP address, name and your email address, if you provide us with this information (for example, when you create a user account or contact us via a feedback form).

Furthermore, we may sometimes collect screen names and other information necessary to provide the Service.

#### Other data

Any information that is available to others in the public domain.

#### Storage of your data

Intelequia Technologies SL is a worldwide company and your personal data are not necessarily being stored in the European Economic Area. We may transfer and store your personal data at our office and associated data centers. By accepting our Terms of Service and/or EULA for the software, you expressly consent to such transfer and storage. We shall use all reasonable endeavors to ensure that your personal data is treated securely and in accordance with this privacy policy.

## **Shared Data**

As set forth in this Privacy Policy, we shall not disclose your personal information to third parties without your consent. The obligation to maintain the confidentiality of your data does not apply in the following cases:

- The specified data is already known to the public; or
- The specified data is required to be disclosed by law, by any governmental or other regulatory authority, or by a court or other authority of competent jurisdiction. Should this be the case, we will inform you of the necessity for such disclosure as soon as reasonably possible.

We reserve the right to disclose personal information about you to affiliated third parties who assist Intelexia Technologies in providing, maintaining, evaluating, improving and delivering the Website, Services and any other Intelexia Technologies products and services. Intelexia Technologies may disclose your personal information to affiliated third parties for the purpose of offering, marketing or advertising Intelexia Technologies products and services to you (such Intelexia Technologies products and services may refer to, include or incorporate third party products and services). In such an event, Intelexia Technologies shall take all reasonable steps to prevent such affiliated third parties from using your personal information for other purposes.
